This Annual Water Quality Report is for the period of January 1 to December 31, 2023. This report is intended to provide you with important information about your drinking water and the efforts made by the water system to provide safe drinking water. Violet WSC purchases water from the CITY OF CORPUS CHRISTI. The City of Corpus Christi provides surface water from Lake Corpus Christi (San Patricio County), Choke Canyon (Live Oak County, Lower Colorado River Authority to Lake Texana (Jackson County).

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline at 800-426-4791.

Contaminants that may be present in source water include:

- Microbial contaminants such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can, also come from gas stations, urban storm water runoff and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulation establishes limits for contaminants in bottled water which must provide the same protection for public health.

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Contaminants may be found in drinking water that may cause taste, color or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor or color of drinking water, please contact the systems business office.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing.

We are responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. DEFINITIONS and ABBREVIATIONS-The following tables contain scientific terms and measure, some of which may require explanation.

Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Action Level Goal (ALG): The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGS allow for a margin of safety. Avg: Regulatory compliance with some MCLs are based on running annual average of monthly samples

Maximum Contaminant Level (MCL): The highest level of a contaminant allowed in drinking water. MCL's are set as close to the MCLGs as feasible using the best available treatment technology.

<u>Level 1 Assessment:</u> A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk. MCLG's allow for a margin of safety.

<u>Level 2 Assessment</u>: A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E-coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

<u>Maximum Residual Disinfectant Level (MRDL):</u> The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG): This is the level of a drinking water disinfectant below which there is no known or expected risk to health.

MRDLG's do not reflect the benefits of the use of disinfectants to control microbial contamination.

NTU - Nephelometric Turbidity Units

MFL - Million fibers per liter (a measure of asbestos)

pCi/l - Picocuries per liter (a measure of radioactivity

ppm - Milligrams per liter or parts per billion - or one ounce in 7,350 gallons of water

ppb - Microgram per liter or parts per billion - or one ounce in 7,350 gallons of water

ppt – Parts per trillion, or nanograms per liter (ng/L)

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, and diarrhea and associated headaches.

Cryptosporidium is of great concern in public water systems that treat surface water for drinking water sources. Resistant to disinfectants. Cryptosporidium can cause gastrointestinal illness in individuals who consume contaminated water. The Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR) is required by congress in order to increase protection from microbial contaminants such as Cryptosporidium sampling over a two year span. The City of Corpus Christi began sampling in April 2019.
