STAGE 1 DROUGHT RESTRICTIONS

BECAUSE CURRENT COMBINED LAKE LEVELS ARE ABOVE 50%, WE ARE NOW IN STAGE 1 DROUGHT RESTRICTIONS BUT STILL ADHERE TO STAGE 2 DROUGHT RESTRICTIONS STARTING ON NOVEMBER 1, 2013.

**THE DESIGNATED WATERING DAY FOR OUR SYSTEM/AREA IS ON
MONDAY**

IF YOU ARE FOUND VIOLATING THESE RESTRICTIONS YOU COULD BE FINED UP TO \$500.00.

RESTRICTIONS ARE AS FOLLOWS:

1. SPRINKLER IRRIGATION – LIMITED TO ONCE EVERY OTHER WEEK ON MONDAY AND IS PROHIBITED BETWEEN 10:00 AM AND 6:00 PM.
2. HAND-HELD AND DRIP IRRIGATION – ALLOWED ANY TIME, ANY DAY WITH A HAND-HELD BUCKET OR A HOSE EQUIPPED WITH A POSITIVE SHUTOFF NOZZLE.
3. CAR & OTHER VEHICLE WASHING – LIMITED TO MONDAY, ALLOWED ANYTIME AT A COMMERCIAL CAR WASH.
4. FILLING/REFILLING POOLS OR JACUZZIS – PROHIBITED TO DESIGNATED WATERING DAY (MONDAY), INCLUDES WADING POOLS.
5. ORNAMENTAL PONDS, FOUNTAINS AND WATERFALLS – PROHIBITED EXCEPT WHERE NECESSARY TO SUPPORT AQUATIC LIFE.
6. GOLF COURSE IRRIGATION – LIMITED TO ONCE A WEEK ON DESIGNATED WATERING DAY (MONDAY).
7. WASHING BUILDINGS, SIDEWALKS, ETC. – PROHIBITED, EXCEPT FOR BUSINESS PURPOSES OR IF IN THE INTEREST OF PUBLIC HEALTH.
8. DUST CONTROL – BY PERMIT ONLY.
9. FOUNDATIONS – LIMITED TO ONCE A WEEK ON THE DESIGNATED DAY (MONDAY); ONLY ALLOWED WITH HAND-HELD HOSE OR DRIP IRRIGATION.

THESE RESTRICTIONS ARE IN EFFECT UNTIL FURTHER NOTICE AND WILL BE ENFORCED.

NOTE: FOR EVERY DROP OF WATER THAT IS USED ON YOUR LAWNS, WATER LOST DUE TO FAULTY PLUMBING, ETC., IS LESS WATER THAT WILL BE AVAILABLE IN THE VERY NEAR FUTURE FOR DRINKING, BATHING, COOKING, ETC. SO PLEASE HELP CONSERVE OUR WATER SUPPLY.
